- **Military:** Persons currently on active duty and who devote all or substantially all of their time to the practice of public relations
- **Retired:** Persons who have maintained active membership in the association at least five consecutive years and who are engaged in the practice of public relations less than half-time
- **Affiliate:** Individuals who provide a service to public relations professionals but who are not themselves engaged in the full-time practice or teaching of public relations
